The CIT rate is a fixed price of \$1,600 per week and there are no discounts. Campers must be entering 11th or 12th grade.

The fees quoted include a \$750 registration fee payable to French Woods Enrichment LLC, Inc. (hereinafter referred to as FWC), which is a non-refundable, non-transferable fee, for a reservation in a program of instruction, including prepayment of costs associated with supervision, room and board for the designated period including laundry services and insurance.

Transportation with baggage to/from camp from New York is an added expense of \$100 each way. Campers that fly to/from camp will not incur any transfer fees if flying on a regular session start and end date. Campers arriving and departing on any other date will be charged a \$300 airport transfer fee each way.

The undersigned acknowledges that he/she is the parent or guardian of the camper designated above and has full authority to enroll the child in a summer camp program. The undersigned further acknowledges that the information contained in this application is true and accurate. The undersigned, by supplying the credit card information below and signing this agreement gives the camp permission to apply tuition charges to the card listed below. Checks should be made payable to FrenchWoods Enrichment, LLC. Signature below is required.

**Each applicant must provide FWC with a deposit in the amount of \$1000.00 at the time the original application is submitted for processing.** It is understood that \$750.00 of the initial deposit shall be a non-refundable, non-transferable registration fee. With the exception of the non-refundable fee, all other fees and/or payments made to FWC unless the undersigned provides FWC with a written request for such a refund prior to March 1, 2023. Thereafter, no refunds will be given for any reason, including, without limitation, whether any such fee or payment was made after March 1, 2023, whether the camper is unable to attend part, or all, of a camp session for any reason at all, including, without limitation, an event of Force Majeure (as defined below herein). All refunds are made on or about May 1st. Payments on the balance of tuition will be billed/charged monthly in equal amounts starting December 1, 2022 with final payments due by May 1, 2023. In the event that the tuition fee is not paid in full by the date the session is scheduled to begin, then all monies on account with FWC shall be forfeited as and for liquidated damages and the camper's reserved place in the session shall be forfeited. No allowance or reduction in the tuition will be given for a camper's late arrival or early withdrawal. This contract is not assignable by any camper without prior written consent of FWC, in its sole discretion.

Authority is hereby granted without limitation to the FWC and its assigns to make decisions and/or authorize treatment of the above-named camper with regard to all medical, surgical or dental matters that may arise while the camper is in the care of FWC including, but not limited to, all matters regarding hospitalization, urgent care, surgery, injections, medication, and/or anesthesia. If it is necessary to obtain off camp medical, surgical or dental services for the camper, such expenses shall be paid by the parent and/or guardian. The parent(s) and/or guardian(s) are responsible for any, and all, out of camp medical, surgical, urgent care, hospital, allergy and/or any other health related costs and expenses incurred by, or on behalf of the camper. Parent(s) and/or guardian(s) are also responsible for providing adequate quantities of necessary medications and allergy serums to the camp in a pharmacy container with doctor's prescriptions at the time the session is scheduled to begin. The New York State Department of Health requires your child's prescription and over-the-counter medications (including vitamins) to be pre-packaged and sealed by dose. Parent(s) and/or guardian(s) are responsible for providing adequate quantities of daily medications to FWC in this manner.

FWC is not responsible for damage or loss of musical instruments, clothing, personal effects or personal equipment used during the camper's stay.

During the camp season, the camper and his/her parent(s) and/or guardian(s) agree to abide by the camp rules and regulations governing health, safety and welfare of the campers and the camp community. Specifically, (a) the possession or use of tobacco, narcotics, liquor or other intoxicants or non-prescription drugs is expressly prohibited both on and off the camp premises; (b) campers may not leave the camp without express permission from the camp director. Violations of these rules or other reasonable regulations will result in dismissal from the camp without tuition refund. The camp reserves the right to dismiss any camper whose conduct is unsatisfactory or inimical to the camp's and the camp community's best interests without a tuition refund. The camp program may include off campus activities and/ or public performances and permission is hereby given for the camper to take part in such performances on and off camp grounds without compensation. The camp may use photographs, statements, articles, names, music, art, & video footage taken of the camper or made by the camper in promoting the camp and camp-related activities through advertising, and/or exhibition.

This contract shall become binding when signed by an authorized representative of FWC without delivery of a copy thereof to the undersigned applicant. If FWC is unable to perform any of its obligations, covenants or agreements under this contract by reason of any natural disaster, "act of god", actions of the elements including flood, earthquake or other similar, war, terrorism, civil unrest, work stoppage, disease, epidemic, pandemic, public health crisis, national or regional emergency, government laws, orders or mandates, changes in applicable law, or any other circumstance that renders the performance of FWC impractical, impossible, or economically difficult, or of any other event outside of the reasonable control of FWC (each being an event of Force Majeure, then all of the obligations, covenants and agreements on the part of FWC shall automatically terminate, without liability on the part of FWC. FWC shall be completely excused from nonperformance that occurs due to any Force Majeure event which renders performance impractical, impossible, or economically difficult regardless of whether such an event was reasonably foreseeable by FWC. This contract contains all the terms and conditions agreed on by the parties, and no other agreement, oral or otherwise, regarding the subject matter of this contract, shall be deemed to exist or to bind any of the parties.

This agreement shall be deemed to have been made in Delaware County, New York, regardless of the order in which the signatures have been affixed. If any provision of this agreement is deemed to be illegal, unconscionable or otherwise invalid, the remainder of the agreement shall not be affected but it shall be construed as if not containing the particular provision held to be invalid.
